Customer Representations and Warranties for JeppView FliteDeck

Pursuant to your request to subscribe to JeppView FliteDeck, you hereby represent and warrant to Jeppesen Sanderson, Inc. (“Jeppesen”) that:

1. YOU ARE **NOT** AN AIRLINE OR AIR CARRIER.
2. You understand that Jeppesen will grant you a license for the use of the JeppView FliteDeck software. The full terms and conditions of the license agreement are set forth in the software itself and on its packaging and include, among other things:
 - Jeppesen’s ownership of all rights, title, and interest in and to the software and its charts and data contained therein, including without limitation, copyrights, patents, trade secrets, trademarks and other intellectual property in the software, charts and data;
 - Jeppesen’s copyright protection in the software, documentation, electronic chart format, charts and compilations of charts and data, which may not be copied, reproduced, reversed-engineered, decompiled, stored in a retrieval system, or retransmitted in whole or in part, in any form or by any means, except as otherwise provided in the license;
 - Restrictions on how you may use JeppView FliteDeck;
 - Jeppesen’s limited warranty that it has accurately graphically depicted the flight procedures prescribed by applicable government authorities, and that it has accurately communicated the information obtained from other sources which is depicted on its electronic charts or other materials. Jeppesen does not design, review, or flight-check any of these procedures and has no authority to alter them. Jeppesen’s flight procedure charts simply depict the flight procedures exactly as designed, flight-tested and prescribed by applicable government authorities. Jeppesen makes no warranty regarding the use of JeppView FliteDeck outside the 14-day period for which it was produced and was effective.
 - Jeppesen’s delivery of the software and any documentation “as is,” and your assumption all risk as to their performance.

 - Your indemnification of Jeppesen from any and all claims, expenses, liabilities and damages, including claims by third parties, arising out of your utilization of JeppView FliteDeck except to the extent that Jeppesen is liable under any express warranty set forth therein.
 - Limitation of Jeppesen’s liability to the price you paid for JeppView FliteDeck and that IN NO EVENT SHALL JEPPESEN BE LIABLE TO YOU OR ANY OTHER PERSON FOR DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL,

EXEMPLARY, PUNITIVE, OR OTHER DAMAGES FROM TORT, CONTRACT, STRICT LIABILITY OR OTHER THEORY ARISING OUT OF ANY CLAIM THAT THE SOFTWARE, ANY FLIGHT PROCEDURE OR OTHER OUTSIDE SOURCE MATERIAL IS DEFECTIVE, UNRELIABLE, UNSAFE OR FAILS TO CONFORM WITH ANY GOVERNMENT STANDARD OR REGULATION.
